Categories

The **DISTINGUISHED SERVICE AWARD** is presented to:

A parent, professional, volunteer, civic group, employer, humanitarian, or any organization that has made significant contribution(s) to enhance the quality of life for person(s) with intellectual and/or developmental disabilities.

The **MEDIA DISTINCTION AWARD** is presented to:

A media individual who has made an outstanding contribution toward creating a better understanding of persons with intellectual and/or developmental disabilities through news article(s), editorials, broadcast reports, pictorial essays, etc. (please include copies).

The **SHELDON DUNN INSPIRATION AWARD** is presented to:

An individual with an intellectual and/or developmental disability, who resides or works in Oakland County. S/he can be a student, young adult, or older person who has made a contribution or achievement appropriate to his/her level of development and can serve as an inspiration to others.

The AL CARTER VOLUNTEER OF THE YEAR AWARD is presented to:

A parent, interested citizen or professional who has freely given of their time to assist The Arc and/or persons with intellectual and/or developmental disabilities. The person may be a professional; however, s/he must not have received payment for the service for which they are being nominated.

The **YOUTH VOLUNTEER OF THE YEAR AWARD** is presented to:

A teen or young adult under the age of 18 years old who has worked significantly to facilitate the inclusion and integration of, or on behalf of, a person(s) with intellectual and/or developmental disabilities.

The **LEONARD CERCONE TEACHER OF THE YEAR AWARD** is presented to:

A classroom teacher or program instructor in Oakland County who has been creative and enthusiastic in teaching students with intellectual and/or developmental disabilities. The nominee for this award must be teaching at the time the nomination is submitted.

The **GOLDEN DOVE AWARD** is presented to:

A retiring, or recently retired, teacher or administrator in Oakland County who has shown many years of service and long-term commitment and dedication to the education of children and young adults with intellectual and/or developmental disabilities.

The EMPLOYER/CONTRACTOR OF THE YEAR AWARD is presented to:

An individual, firm, industry or business in Oakland County that employs a person(s) with an intellectual and/or developmental disability. The employer/contractor must employ the person(s) in accordance with state laws and regulations. This may include supported employment facilities. Please include the name and address of the employer/contractor and the contact person to whom the award letter should be sent.

The **PROVIDER OF THE YEAR** is presented to

An Oakland County based provider, residential or vocational, who maintains a consistent, positive, and nourishing community-based setting for persons with intellectual and/or developmental disabilities.

The **INCLUSION LEADERSHIP AWARD** is presented to:

A person(s) or group of individuals who, through their diligence and dedication, have strived to make inclusion a priority in education and/or community-based services for persons with intellectual and/or developmental disabilities in Oakland County.

The **COMMUNITY LIVING AWARD** is presented to:

A group home, foster home, family foster home, semi-independent living situation or apartment setting in Oakland County that has provided community living alternatives for persons with intellectual and/or developmental disabilities. The living environment must be comfortable, stimulating and home-like. Please provide the name and address of the home manager and the home provider in your narrative and/or support materials.

The **ROBERT THOMAS SUPPORT PROFESSIONAL AWARD** is presented to:

A social worker who displays exceptional concern for persons with intellectual and/or developmental disabilities and shows his/her concern by providing quality care.

The **VOCATIONAL SERVICE AWARD** is presented to:

A job coach, direct care worker or supervisor who helps individuals with intellectual and/or developmental disabilities obtain and maintain employment within the community.

The **RESIDENTIAL SERVICE AWARD** is presented to:

A direct care worker or supervisor in a group home or personal residence who exhibits genuine concern for persons with intellectual and/or developmental disabilities and positively affects the lives of the individuals living in the home.

The **EDUCATIONAL SERVICE AWARD** is presented to:

A para-professional, occupational therapist, physical therapist, speech pathologist, or psychologist who advocates for children and young adults with intellectual and/or developmental disabilities in an educational setting.
